We have a storage space under customs surveillance with easy access to the city belt of Bucharest and to the Highway A2. The surface of our warehouse is 860 m_2 with 9.0 m clear-height at the eaves.

Because we care about environment, the industrial complex where we are situated uses a 2.2 MW Photovoltaic renewable energy project with PV roof panels.

The Integrated Management System and AEO Authorization











Protecting our position as outstanding provider of *national and international freight transport*, *storing* and *handling services*, is a boldly goal to us, considering that our objective is to undertake our business in accountable manner as to the environment, civil society and employees.

For the achievement of such desideratum, we always bear in mind:

- satisfaction of our customers;
- promptitude in delivery of services;
- o compliance with the legal provisions and other industry applicable requirements;
- o employees' involvement and motivation;
- o low costs of services, ensuring:

Therefore, we decided to implement and maintain an Integrated Management System, in conformity with in accordance with ISO 9001:2015 and ISO 14001:2005 and SR OHSAS 18001:2008, aiming at incessant improvement of the organization's performances and also that successfully complements the AEO approval.

Under Article 38 of Regulation 952/2013, there are two types of AEO authorizations:

- AEOC customs simplifications;
- AEOS security and safety;

The type of AEO authorization obtained by MA.RA Logistics Quality is AEOC - customs simplifications.

Access to customs simplifications shall take place in accordance with the customs rules in force and this simplification shall entail:

- Reducing the number of physical and documentary checks;
- Priority treatment of shipments if selected for control;
- Possibility to choose the location to perform the controls;

We care about the Environment



Just as all industries are making great efforts for greening, also the transport industry has to make a significant contribution. We are involved in this environmental protection movement, becoming a logistics provider of ecological services. We are aware that as transport progresses, **CO2 emissions** can be significantly reduced.

MA.RA Logistics Quality aims to efficiently plan and optimize the use of high capacity vehicles. This has considerably improved load efficiency and service quality. This has reduced the number of low-efficiency vehicles with low volume, as well as a significant reduction in carbon emissions. In our road transport we use **Euro 5** and **Euro 6** trucks precisely because we want to protect the environment and have **low carbon emissions**.

Our reports regarding CO2 emissions follow the European CEN standard EN16258:2012.

It sets out a common approach and framework for calculating energy consumption and greenhouse gas emissions associated with transport services.

Safe and Secure



As the security is an important factor, an alarm system has been installed to protect the entire property against intrusions, and all the goods held in the warehouse are always controlled by a video surveillance system which, also guarantees also the carrying of goods on-loading and off-loading.

We are using the following systems and methods for safety and security:

- Personal badge for access control in every room
- ► Intrusion detection system 24/24 hours
- ➤ Emergency alert 24/24 hours
- Fire alarm system
- High resolution CCTV camera system digital video surveillance 24/24 hours
- Access in the logistic park controlled by security company 24/24 hours
- Supervised parking place


Observing the company security policy, many security system guidelines have been introduced into our warehouse. The input is controlled by an emergency alert software which instantly broadcasts evacuation and other urgent messages immediately.

The emergency broadcasts are delivered to each sector and room of the warehouses. The access control and all security systems are managed by corporate security and local private security company.

Our CCTV monitoring system supplies - on request to corporate security - insurance company information loss, damage and for any internal and external official investigation.
